1.Why are you seeking your office?

I have never run for public office before. However, I have a desire to serve my community and a strong belief in the importance of active civic engagement. I am now ready to invest fully to the commitment of making a positive difference in my community and believe that the best way for me to do that is by serving as County Chairman.

2. What do you expect to accomplish if elected?

I intend to accomplish the following: (i) ensuring our fiscal stability and the effective and efficient use of resources; (ii) ensuring that services are delivered to our residents in a professional, efficient and cost effective way; (iii) ensuring that our quality of life is sustained and improved upon; and (iv) ensuring that we foster a vibrant economic environment that is conducive to economic development and encourages entrepreneurship, small business investment and quality job growth. 4. Pick any one issue. Expand on how you will address it.

department heads identify spending that is either discretionary or can be delayed to a subsequent fiscal year without substantially impacting operations or service delivery.
