# 1. Why are you seeking your office?

The Gwinnett Sheriff's Office is in need of desperate reform. #### 4. Pick any one issue. Expand on how you will address it.

I support significant reform of the 287(g) program. Gwinnett 's reported 287(g) instances totaled close to 5,700 in 2017. Most of the people detained under 287(g) are being held for minor offenses such as driving without a license and ICE should not be involved. These would merely be ticketed offenses in other counties. It should be a priority to protect and serve all people in Gwinnett and have the trust of the community. As Sheriff, I will institute a policy that enforces 287(g) only on major felony cases and ends racially based enforcement.
